




**Derating Curve:**


## Normalized Off-State Terminal Voltage vs. Ambient Temperature:

## Peak On-State Terminal Voltage vs. Ambient Temperature:









Moreover Würth Elektronik elSos GmbH & Co KG must be informed about the intent of such usage before the design-in stage. In addition, sufficient reliability evaluation checks for safety must be performed on every electronic component which is used in electronic circuits that require high asteging and reliability functions or performance.
