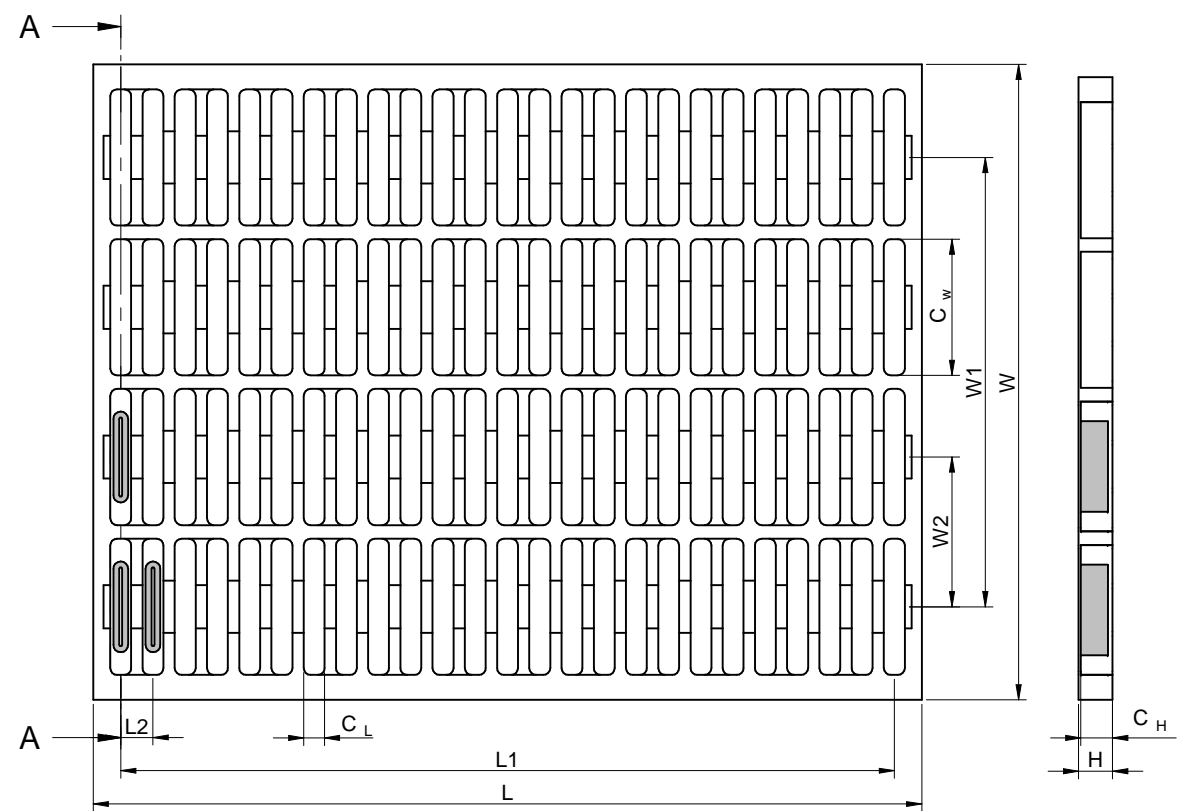
Typical Impedance vs. Frequency Characteristics:



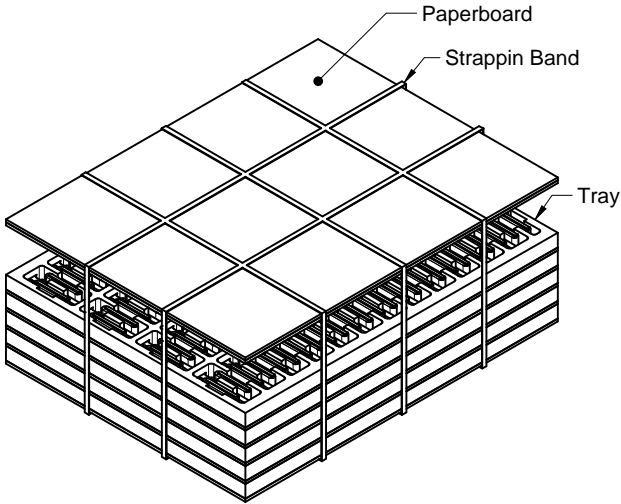

Product specific:

Cleaning and Washing:



Packaging:


