#### **Cleaning and Washing:**

• Washing agents used during the production to clean the customer application might damage or change the characteristics of the component. Washing agents may have a negative effect on the long-term functionality of the product.

#### Potting

• If the product is potted in the customer application, the potting material might shrink or expand during and after hardening. Shrinking could lead to an incomplete seal, allowing contaminants into the core. Expansion could damage the components. We recommend a manual inspection after potting to avoid these effects.

#### **Storage Conditions:**

A storage of Würth Elektronik products for longer than 12 months is not recommended. The material characteristics of the electronic
components create a limiting factor for the storage stability. Therefore, all products shall be used within the period of 12 months based
on the day of shipment.

- Do not expose the components into direct sunlight.
- The storage condition in the original packaging is defined according to DIN EN 61760-2.
- The packaging of the products (Moisture Impermeable Bag) is to maintain the required moisture level of the plastic housings. To ensure this moisture level, the product either has to be stored in the original sealed packaging or needs to be stored in a humidity and temperature controlled storage room. Otherwise, the product may lose the required moisture level and its mechanical properties.
