#### Product specific:

#### Cleaning and Washing:

- Washing agents used during the production to clean the customer application might damage or change the characteristics of the component. Washing agents may have a negative effect on the long-term functionality of the product.

#### Potting:

- If the product is potted in the customer application, the potting material might shrink or expand during and after hardening. Shrinking could lead to an incomplete seal, allowing contaminants into the core. Expansion could damage the components. We recommend a manual inspection after potting to avoid these effects.

#### Storage Conditions:

Otherwise, the product may lose the required moisture level and its mechanical properties. In this case, you can re-condition the products according to the internal standard WE-Standard 1581 to ensure the required moisture level in the plastic.



#### Packaging:

- The temperature rise of the component must be taken into consideration. The operating temperature is comprised of ambient temperature and temperature rise of the component. The operating temperature of the component shall not exceed the maximum temperature specified.


