#### Product specific:

##### Cleaning and Washing:

- Washing agents used during the production to clean the customer application might damage or change the characteristics of the component. Washing agents may have a negative effect on the long-term functionality of the product.

##### Potting:

- If the product is potted in the customer application, the potting material might shrink or expand during and after hardening. ##### Packaging:
